□ November 2022: Coordination + French group December 2022: Publication of the call □ France positioning □ Survey **J**anuary 2023: □ Information meeting Final version of the SRIA

### Next steps for building the PSFS

- □ Submission at the latest on April 12th, 2023
- ❑ March : Finalising the Part B by the middle of March (for proofreading), and completing Part A (including administrative forms, budget).
- February: Writing the proposal Part B with WP leaders/co-leaders and task leaders (including interactions and exchanges between WPs). Expand the consortium. Positionning partners in the different tasks considering their expertise, wishes/constrains and balance between countries/organisations.
- □ January: Appointing WP leaders/co-leaders and task leaders to coconstruct the PSFS proposal. Validate the work plan and first round of consortium partners



### **PSFS** building process

- **Survey** for participation in the future PSFS launched in December 2022 (still open)
- Establishment of a core group of organisations (already involved in the PSFS Narrative, Template, in the SRIA, have expressed interest through the survey) to co-construct the WPs, define WP leaders and expand the consortium
  - □ Consortium = funders + RPOs (Research Performing Organisations)
  - Only RPOs that will provide in-kind contribution and that will have an operational role could take part in the consortium
  - Not all RPOs answering the survey will be in the consortium at the end (selection to be made with the core group based on expertise, wishes/constrains and balance between countries/organisations)
  - RPOs not in the consortium <u>will have the possibility to apply to external calls</u> after the PSFS will be accepted
  - □ To be invited in the consortium the organisation <u>must have filled in the survey</u>


# PSFS survey results 1/2 (2023/02/03)

Survey launched in December – results from answers received by February 3 (survey still open)

- > 150 answers received Thank you!
- 31 organisations expressed their interest to fund in cash external calls (30 from MS-AC + 1 third country)
- 9 funding organisations are pending, most of them indicated a potential funding commitment
- Preliminary commitment > 170 M€ (for the whole partnership's duration)
- 8 organisations (mainly RPOs) expressed their interest to provide in-kind contribution
- Preliminary commitment > 38 M€
- Many RPOs expressed interest to apply to external calls (cash-calls)


